CTSO has written a proposal allowing employees to purchase additional paid time off. Proposal was shared with ND SSS. ND SSS made the recommendation for HRC to review the proposal to see if this would be feasible under current policy/Century Code.

## **SBHE Report-Staff Senate Board Member Report:**

**a. Updates:** Hoffarth indicated that the Chancellor will be bringing a resolution to the SBHE regarding the Tuition Waiver Initiative with a proposed policy revision. The revisions would need to be distributed to the

appropriate councils for discussion/approval.

Hoffarth attended a higher education board conference in Florida. In one session, colleges shared the outcomes of holding a Faculty Shadow Day in which board members shadow a faculty member for a day to see what a day entails for the faculty members (teaching, advising, committee work, tenure portfolio development, etc). In the colleges that have implemented this initiative, positive results have been found in the working knowledge of colleges and relationship building with faculty and board members. Hoffarth is working to develop a pilot program at UND to allow board members to shadow faculty and staff throughout a day and potentially inviting legislators to shadow faculty and staff.

HLC will be interviewing SBHE members next week in follow-up to the complaint filed.
