## III. Approval of Agenda

a. Motion to approve agenda made by Lisa Braun (MiSU) and seconded by Pam Henderson (UND). The agenda was unanimously approved.

## IV. Approval of Minutes

a. Motion was made by Katie Petersen (WSC) and seconded by Pam Henderson (UND) to approve the March 14, 2016 minutes. The minutes were unanimously approved.

          - 1. Envision 2030 will be a round-table type of meeting with other stakeholders such as legislatures, Department of Public Instruction etc. to discuss "What will a student look like in 2030 and what do we need to do to prepare?"

- c. Human Resource Council (HRC): Lisa Braun reported on the following items:
  - i. Next meeting May 24th and 25th in Wahpeton, ND.
- d. SBHE Task Forces
  - i. Cost Containment Emma Tufte (VCSU) reported no update.
  - ii. Shared Services Diane Hillebrand (UND) reported still in the data collection phase. Plan to have an early May wrap up meeting prior to presentation of findings at the next SBHE meeting.
  - iii. Tuition/Fees Model Andy Wakeford (LRSC) reported that last meeting was held in February. March and April meetings were postponed due to change in SBHE meeting schedule.
- VI. Business Agenda
  - a. June SSS F2F Meeting June 21st and 22nd
    - i. Katie encouraged SSS members to complete the Qualtrics Survey.
      - 1. Block of rooms set aside at the El Rancho Inn.
      - 2. WSC dorm rooms are also available.
      - 3. WSC will sponsor the breakfast on the morning of June 22.
      - 4. Meeting will also be available via IVN connections.
      - 5. Group dinner is optional at own cost on June 21.

- b. North Dakota State Staff Senate Resolution: At the previous SSS meeting, Amber Flynn (UND) presented a proposed North Dakota State Staff Senate Resolution to ask that all eleven NDUS institutions request that Presidents of institutions across the NDUS endorse
  - i. The prioritization of the academic mission of each respective institution when making budget decisions and
  - ii. The utilization of staff input when recommending resource reallocation and
  - iii. Report to the senate chairs and ND SSS chair exactly how staff participated and provided input into the budget reallocation process.
    Greg Carlson (VCSU) made a motion, seconded by Daniel Erichsen (NDSU), to reject resolution. Roll call vote results: Reject 7 votes, Abstain 5 votes.
    Motion to reject endorsement carried.
- c. ND SSS Bylaws Membership terms:
  - Bob Heitkamp (NDSCS) proposed a review of the SSS Bylaws to determine whether or not the same membership terms are being used by both the membership at the state level and at the local level. Emma Tufte (VCSU) and Grant Carlson (VCSU) agreed to assist with the review.
- d. Representatives for NDUS Retirement Plan Oversight Committee: This committee is seeking representation for two positions on this committee; one to represent the 2 year colleges, and one to represent the 4 year universities. This committee will meet three times a year. The following three SSS members have agreed to submit their names:
  - i. Laura Fetting (DSU)
  - ii. Diane Axness (NDSU)
  - iii. Katie Peterson (WSC)

#### VII. Open Discussion

- a. Sanford Health Plan: Survey results were reviewed. Sharon Kilzer (DSU) summarized the findings into three categories:
  - i. Communication
  - ii. Transition
  - iii. Expense reimbursement

Following discussion, it was suggested that the findings being forwarded to NDPERS. It appears that there is an overall sense of satisfaction regarding health coverage and billing. This survey does not reflect upon individual health care practitioners or providers. It is also noted that some of the concerns appear to be related to providers who are or were not part of the network.

b. Nominations for Officers: Diane Hillebrand announced that nominations are being accepted for SSS Officers. Election will take place at the June F2F meeting.
